

## ONVIF Member Participation FAQ

### Why should members participate in ONVIF?

As ONVIF continues to work on next generation profiles, one of the keys to success is increased member participation. Amplified support and involvement from members not only benefits ONVIF and the organization's objectives, there are also numerous advantages to each member as well. It cannot be emphasized enough that the entire success of ONVIF is built on our member's engagement and contribution of expertise in the field of interoperability.

### What are the benefits of member participation?

A few of the top benefits members will experience with ONVIF participation include:

- Ability to be an early adopter with early access to intellectual property
- Getting the latest news on ONVIF's status and roadmap
- Direct participation in discussions that contribute to the development of the standard
- An opportunity to influence the market and be a part of a growing IP interoperability community
- Learn how ONVIF's standards requirements can ensure interoperability among physical security products

### Who can participate?

All members can participate but involvement varies depending on membership level.

- Full Members may attend, contribute, chair, vote in committees and work groups, as well as participate as a steering committee member and vote for a steering committee member. Full Members also have use of the Member Forum and the Working Group Platform.
- Contributing Members may attend and contribute to committee and working group activities, as well as vote for committee members (except for steering committee). Contributing Members also have use of the Member Forum and the Working Group Platform.
- User Members have access to the ONVIF Member Forum and use of conformance tools and the ONVIF member and profile logos.
- Observer Members have use of conformance tools as well as the ONVIF member logo.

### What are the ways a member can participate in ONVIF?

There are multiple ways a member can participate but some activities may be restricted depending on membership level. Ways to participate include:

- Join an ONVIF Committee (elections held Q4 annually)
- Join an ONVIF working group
- Engage on the ONVIF Member Forum
- Engage on the ONVIF Working Group Platform



### **What committees and work groups are there and how does a member learn more about ways to participate?**
